increased brake drag.

The National Motor Vehicle Title Information System (NMVTIS) is an electronic system that contains information on certain automobiles titled in the United States.  commercial vehicles if those vehicles are not included in a state's primary database for title records (in some states, those vehicles are
 managed by a separate state agency), although these records may be added at a later time.

- Information from junk and salvage yards receiving a "cash for clunker" vehicle traded-in under the Consumer Assistance to Recycle and Save Act of 2009 (CARS) Program.
