Summary Harley-davidson is recalling certain model year 2009-2012 touring, cvo touring and trike vehicles

manufactured from june 6, 2008, through september 16, 2011. See the above list for the models included in the recall. The rear brake light switch may be exposed to excessive heat from the exhaust

system.

Consequence The excessive heat may cause the switch to not activate the brake lamp or activate the brake lamp

when no brake is applied and/or cause a brake fluid leak at the brake light switch, affecting rear brake performance. Either condition may increase the risk of a crash.

The National Motor Vehicle Title Information System (NMVTIS) is an electronic system that contains information on certain automobiles titled in the United States.
